- It's party time in the subdivision, Derby has come and gone, Memorial Day weekend festival with the country club pool opening, and graduations. While parking on the roadways is illegal, exceptions are made; park in the proper direction, do not block intersections or driveways, and don't park on both sides of the street.
- The area next to the MSD pump stations again is a hot spot for young adults to park late nights and very early morning.
- Conducted numerous house watches for residents while they were out of town.
