Comments and Actions:

1. "The Pit" (a popular hangout for young teens) was active this month until the individuals learned that they were sharing the water with some snakes.
2. There have been reports of individuals looking into windows, trying doors or roaming through yards. Once again I have started foot patrols behind homes along the golf course.
3. The investigation into the damage to the street sign at Moser Farm Road and Worthington Lane is complete. Through the efforts of both the off duty officers and information received from the GlenOaks Community the responsible party was located and restitution is forthcoming.
4. Numerous young adults continue to roam the roadways of the subdivision in violation of the curfew within Jefferson County. So they are now roaming in the Oldham County side of the subdivision where there is no curfew. There were some issues in the Oldham County areas of the subdivision, to assist the Oldham County Police, all young adults roaming the subdivision late at night or early in the morning will be stopped; information taken; and forwarded to the Oldham County Police Department.
5. I have found on several occasions children unsupervised and individuals not authorized to be around the lake area. In all incidents I have sent these individuals home or out of the subdivision.
6. The "Trash Collectors" are still collecting items left at the curb. When I locate one of them, I verify who they are and if there is an outstanding warrant for them. **Do Not** place any items in your trash that would provide an **opportunity for them to use your identity.**
