On both occasions they informed me there were friends of someone living within the subdivision and they gave them permission to use the lake. I informed them without the resident had to be with them, I advised them to leave and return with the resident.
- I monitored the area next to the MSD pump station as it is a hot spot for young adults to park late nights and very early morning,
- I conducted numerous house watches.
