COMMENTS:

Last month again I had several complaints that I looked into. Some individuals I was able to speak with and some issues are still unresolved.

First, a lot of vehicles are just driving to fast within the subdivision both residents and non-residents. Pizza drivers going to and from deliveries continue to be a problem. I now know who owns the dark blue BMW that speeds in and around Fairways and Worthington Lane (Oldham County section).

Secondly, it was brought to my attention (last month) the reckless driving of a golf cart (passenger style) driving on the wrong side of the roadway, driving through residents' yards and driving on the sidewalks. This golf cart was seen several different times again this month doing the same reckless activities. I am still looking for the young adults (15/18 years old) who are being a nuisance in the subdivision. IF YOU have any information contact the Homeowners Association @ 736-7676.

Next, I received reports of suspicious vehicles within the subdivision as well. I was not able to locate either the white van, or the silver Lexus. The last complaint I would like to address is the issues between the GlenOaks Country Club and the residents of GlenOaks subdivision. The chief complaints that I received were maintenance personnel with mowers or maintenance vehicles on the roadways, golf course attendants with carts on the roadways, and some golfers operating golf carts on the roadways. I spoke with the supervisor of the maintenance department, the Country Club Pro and the Operating Manager of the club. As for the personnel directly under their supervision, they have spoke with them **twice**; they will also speak with the golfers as well. From the Country Club side, sometimes they have special tournaments and all the golf start at the same time on different holes. This is not a weekly occurrence but sometimes there will be a need for them to operate their golf carts on the roadway for a short period of time. I hope as adults we can understand both sides of this issue. I am trying to monitor these complaints very closely.

Again, during the month there were several vehicles parked at the Glen Oak County Club late evening and early morning hours, on a check of these vehicles none were stolen and most belonged to non-residents of the subdivision.

Again during the month I conducted several house watches.

Finally, "Thank You", to everyone who has stopped me, emailed me, or paged me and commended me on the way I perform my duties. Sometimes police officers hear only negatives comments and complaints. It's nice to hear a kind word now and then. Again "Thank You", for your kind words.
