Comments and Actions:

1. **Disregarding at stop signs** was the number one problem this month. The failing to stop at the intersection of Worthington Lane and Stone School Road or Worthington lane and Elder Lane are the greatest areas of concern. **Speeding**, was the #2 problem with citations issued for speeds nearing 40 mph.
2. The lake continues to see plenty of action with the warm weather – there were again two occasions that I found children NOT supervised by an adult using the lake. On both occasions parents did arrive later and were upset with the Homeowners Association posted rules not allowing unsupervised children.
3. This month there was a deer struck and killed near the entrance to the subdivision. I have received several complaints about that it was still in the roadway. I advised them that I had dragged it from the roadway curbside and metro public works was informed to pick the dead carcass. However I was informed prior to their arrival, someone had removed the head from the animal
4. I monitored the area next to the MSD pump station as it is a hot spot for young adults to park late nights and very early mornings.
5. I conducted numerous house watches.
